MOTIONS AND PROPOSALS



The priority for the Commission is to support exhibiting. The Commission supports thematic philately through:

- education (seminars open to the public and through the newsletter about thematic philately generally),
- training (workshops for exhibitors) and
- judging (quality control of the judging as done at exhibitions).

We summarize these activities as supporting and maintaining "EXHIBITING EXCELLENCE" and "JUDGING EXCELLENCE".

Why this is important!

Up to 2004 it was self-evident having the Commission president and/or vice president plus further Bureau member(s) on any FIP jury. The system started to change after 2004, when Bureau seats were allotted for periods of four years, and no more "eternally" as they had de facto been in most Commissions. The sad consequence for thematic philately was that those changes discussed at the team leaders' meeting in 2003 became implemented in some seminars but never in judging at FIP shows. Observation from the FIP shows of the last three years is that reliability of scores and medals diminish to an alarming degree, especially with the three highest medal levels. Our goal must be not only to stop this trend but to considerably improve the validity of the assessments.

Suggestions!

- One should not be able to become a judge if one not is an active exhibitor in that class one judges
- Even if one is an active exhibitor one might not be "qualified" to become a judge
- The qualifications to become a judge must be set as high
- The high qualifications demanded on judges must include other qualifications than received award only
- The received award must be at least a Large Vermeil medal on FIP level
- For Team Leaders the received award must be Gold medal on FIP level

- Active” means that the judge needs to continuously exhibit in the class he judge and also to confirm the qualification medal
- All judges must continuously participate in training and education
- Without being active as exhibitor and/or participate in training and education, the judge’s authorisation to judge will be withdrawn
- The same practices must be implemented on both FIP and national levels

STATEMENT OF WORK FOR THE NEXT TWO YEARS

When the current leadership of the Commission was elected in 2012, a roadmap for activities from 2012 to 2016 (the election period) was set and fully implemented with the FIP leadership.

Thematic Administration is more intense than other classes

- *Thematic exhibits use exhibition forum and feedback to help their evolution and development*
- *Thematic philately has the need for comparable judgment from one exhibition to the other so that points and medal levels do not have wild variances.*
- *Constant need for juries to:*
 - *Have continuous training and formal reflection*
 - *Discuss their work through regular roundtables*

While these fundamental criteria seem to be similar to the other classes of philatelic exhibitions, their nuances are actually different because of the importance of “Development” (“Treatment”) in Thematic Philately Class.

- *Requires more:*
 - *Training*
 - *Experience in judging*
 - *Importance of mentorship.*
 - *Quality Assurance (Experienced Oversight)*

Thematic philately requires more training and experience in judging and mentorship than other classes because of its more rigorous intellectual framework in presentation and organization – what could be called “structural treatment” (although in thematic philately, we use the term “Development” -- although “storyline” is gaining widespread use in the thematic area as well).

To maintain a strong follow up in this class of philatelic endeavors, thematic philately needs quality assurance through the efforts of experienced oversight and guidance that takes time to build. Otherwise, philatelists will become demoralized by what could be conceived as “randomness” or “arbitrary judgments.” All members of the Commission are expected to use their knowledge and experience in monitoring for consistency in the evaluations of exhibits being done by thematic judges.

Request for Direction from the FIP President and Board

The Thematic Commission is anxious to support ideas and programs that emanate from FIP's leadership.

- What will the nature of communications from the FIP be for the Commissions and their Chairmen?
- Are there defined roles for Commissions and their Chairmen at this time – other than those we are currently performing?

We are still very much looking forward to any direction that President Tay and the Board wish to give to us at this time. We see ourselves on the Thematic Commission as a resource to the FIP leadership in our specialized area and wish to support the general goodwill toward and reputation of FIP within the global community.
