# THE COMMISSION MEETS IN BANGKOK

### Friday, October 8th, at 12.00, at the Queen Sikirit Hotel

Dear Delegate,

This meeting of the Commission should concentrate on the work programme defined in Genova last year, which covers all the different aspects of the mission of a FIP philatelic Commission.

In spite of the formal agenda. we have to make it a working meeting rather than a business meeting, even if the time available is not much for a working session. It is a matter of fact that the productive meetings, where a real progress is achieved, require a full week-end, as is was in Lucerne, in Lisse or in Barcelona. I fully understand those delegates who cannot be in Bangkok on the basis

that a two hours meeting cannot justify a long and costly trip, but at the same time they must realise that FIP approach is to have, first of all, a universal representation and get together. This allows to widen our international base and bring in new contributions, which can become very active over time. Until the seventies, every meeting of the Commission was held in Europe. Now we are meeting in every continent, because thematic philately has a world wide representation. The new Federations are coming it with enthusiasm and I am sure that, this time, we will have a larger attendance of Asian delegates. They will understand better the Commission's role and activities and, in the future, work closer with the other delegates.

It is regrettable that some delegates are acting more as post box than as active representatives of their Federations. These delegates neither

take part to meetings even when they are held in locations not very far from home nor they do correspond with the President or other members in charge of specific tasks. I expect more cooperation from them, either through a real participation or in asking their Federation to appoint another person more available to cooperate. As long as they represent a

# MARY ANN OWENS SIGNS THE ROLL OF DISTINGUISHED PHILATELIST

Mary Ann Owens, delegate of U.S.A., has been elected to sign the Roll at the 75th Philatelic Congress in Edinburgh together with Istvan Gazda, Otto Hornung, Hiroyuki Kanai, Knud Mohr, Brigadier Virk. Mary Ann has been elected for "work done or honours obtained in the thematics (topical) discipline. She had already been awarded the ATA Distinguished Philatelists Award and the Luff Award.

# EERO ELLSTEN wins the Championship Class at NORDIA '93

The "Photography" exhibit got the Gran Prix at NORDIA '93, in the Championship Class open to all exhibits who have received at least two FIP Gold medals. The award was given by a Jury of 13 members, including Gunnar Dahlvig. His comment "Never before a thematic exhibit got a GP in the Championship Class and I think that it will of tremendous importance for thematic philately in the Nordic countries. We are fully accepted as equals by the traditionalists".

# THE AFPT: 40 YEARS FOR THE PROGRESS OF THEMATIC PHILATELY

The Association Française de Philatélie Thèmatique (AFPT), is celebrating its 40th anniversary with three exhibitions in Alby, Paris and Lens. The Association, which was founded by a group of famous pioneers of thematic philately including Abbé. L. Braun, Prof. E. Olivier, Dr. J. Daubresse and Marc Dhotel, past secretary of this Commission, over the last ten years has reached a very high level in terms of membership, activities, publications and success of its members at international exhibitions.

#### SEMINARS PROGRAM AT TAIPEI '93

To support the tremendous interest for philately in the country the organisers of TAIPEI '93, Asian invitation international stamp exhibition, scheduled several seminars, mainly devoted to thematic philately. As lecturers they invited Dr. Morolli, Mary Ann Owens ("The Joy of Thematic Philately"), Betty Van Tenac ("Aspects of Thematic Philately") and Joan Murphy ("Thematic Philately"). At least 80 participants attended each three hours seminar and were given the text of the lectures in English or Chinese and a bilingual handbook with all the FIP SREVs and Guidelines. An

interpreter translated all the presentations and the many questions and answers.

# SIX NEW FEDERATIONS APPLY FOR FIP MEMBERSHIP

Six Federations are looking forward to being admitted to the FIP at the next Congress: Albania, Armenia, the Czech Republic, Slovakia, Slovenia and Ukraine.

# REPORT TO THE FIP CONGRESS

### BANGKOK, 10-11 OCTOBER 1993

#### 1. Delegates

In the last period new delegates have been appointed to represent countries where thematic philatelic has become more popular among philatelists. As a result, the Commission consists of the representatives of 53 Federations.

### 2. New Organisation of the Commission

For the term started with the elections held in Granada, a plan of activities has been defined and the relevant responsibilities delegated to the members of the Bureau and other delegates who have been asked to join the working teams.

#### 3. Granada '92

The Commission and the newly elected Bureau met at Granada '92. The main subjects were the approval of the SREV and the Guidelines. The exhibition was the occasion for testing new type of communications between judges exhibitors. In a seminar, led by Dr. Morolli, the summary results of the evaluation were presented, explaining the main reasons for loss of points on each criterion, A comprehensive discussion helped to reach á understanding of the problems and the possible improvements. Exhibitors attending the seminar expressed a very high appreciation for this initiative.

#### 4. Genova '92

The number and the level of the exhibits was the best success for the 6th world thematic exhibition held under FIP Patronage. The attendance of the public and the many meetings which involved members of the Commission made this event very remarkable. The Italian Thematic Association (CIFT) arranged Seminar with the support of Dr. Morolli, who of Thematic the situation presented Associations around the world thanks to the participation of more than 20 organisations who contributed with their national data; the presentation was published on the same occasion.

The Commission and the Bureau met and started the discussion on some key projects. Also the organisation and the activity plan were finalised and approved.

#### Thematic SREV and Guidelines

The SREV was reviewed and a small sentence added. This text is already in the GREV but needs to be repeated also in the SREV (see Box at next page).

The Guidelines - also after the experience of the Jury of Genova '92 - need some more definitions on the subjects of Philatelic Studies and Borderline material (e.g. fiscals).

#### Modification to SREV 3.2.1

Last sentence:

The plan must be presented in a page at the beginning of the exhibit, written in one of the FIP official languages. It should detail the contents of the collection, its subdivisions, and the size of the chapters shown.

Comment: Experience at Olymphilex '92 and Genova '92 has shown the need to call the attention of exhibitors on the language of the plan page. Since the SREV has traditionally been the only reference paper for the thematic exhibitors, it is considered necessary to repeat this requirement, already stated in the GREV.

This change, approved in Genova, will be considered by the first FIP Congress in which the Board will accept modifications to the text approved in Granada. Up to that date no proposal for change will be discussed. Anyway, due the formal content of the change, there is no problem to wait for the approval. Of course delegates representing non FIP speaking countries are strongly recommended to inform exhibitors and national Commissioners about this requirement, compulsory for all FIP classes.

#### 5. Activities in 1993

#### Philatelic Studies

The working team has already started with some introductory presentations in Genova and with the exchange of proposals among members. The objective is to reach a satisfactory definition, taking care of the needs and the philatelic tradition in some areas where there is a wealth of philatelic material, and of the requirements of thematic development. The problem has become more important after the unification of the evaluation criteria in our class, which impacted the so called "documentary" exhibits, traditionally bound to philatelic studies.

#### Judging

A Seminar called by the SMV (Swiss Thematic Association) in Thun and led by Dr. Bergman was the occasion for the representatives of Switzerland and the nearby countries to review with Dr. Morolli the key problems of judging at FIP level and to make proposals to the FIP Vice Presidents who attended this working session.

#### New Trends in Philately

Mr. Dahlvig has started the work of a team interested to collect information about new collecting and exhibiting trends in the different countries.

#### **Detailed Criteria**

This study group is addressing the definition of sub-criteria in order to guide the judges towards a more consistent and analytical approach of evaluating the exhibits

#### 6. Thematic Groups

The second edition of the publication "Thematic Organisations of the World" was prepared by Dr. Bergman in co-operation with the President and printed thanks to Dr. Veschi's support at Genova '92. Copies were sent to Federations and delegates.

#### UPDATE OF SREV AND GUIDELINES

The Commission will continue to work on this matter, in the following way:

#### SREV

Modifications suggested by experience, e.g. to correct inconsistencies or to make some statements more clear, will be collected by the President, discussed with the working group and then presented to the delegates on these pages. In due time they will be submitted for approval to the FIP Congress when the subject will be on the agenda.

#### Guidelines

Proposal for changes must follow the same process. Anyway, the decisions of the Commission will be put together in a "temporary annex" to be used as a reference by experts and judges and to be brought to the attention of the exhibitors s a further clarification. When FIP will start a new round for updating the Guidelines, this text will be incorporated in the Guidelines.

#### NEW TRENDS IN PHILATELY

Gunnar Dahlvig has requested all Delegates to report about initiatives in their countries on new approaches in thematic philately, on the introduction of modern philately and the relevant ways of implementation. Furthermore the research intends to highlight new types of exhibitions related to stamps, even irrespective of the traditional approaches of philately.

#### IMPLEMENTATION OF JUDGES

It is important that the new SREV and the Guidelines are brought to the attention of the thematic collectors in the most appropriate way, i.e. translating the documents and making them

understood by national jurors and by exhibitors through seminars at national and regional level. This survey, coordinated by Gunnar Dahlvig, is not only a request for information, but should put a clear question to all delegates to plan on time an appropriate education and information program.

# NEW SLIDE PRESENTATION ON THEMATIC PHILATELY

On the occasion of TAIPEI '93 the president of the Commission developed a new presentation of about 50 slides (transparent foils for overhead projection) following the thread of the updated thematic Guidelines. The first version of this presentation was developed since India '89 and made available to the FIP members via the FIP Implementation Committee. The distribution of the new version will be defined with the FIP officers in Bangkok and the relevant decision published in our next issue.

#### PHILATELIC STUDIES

Manfred Bergman has presented a detailed analysis after his presentation in Genova, rich of examples developed in order to illustrate the points made. Also a thorough contribution has been sent by H.-W. Bosserhoff; after a consultation with other German experts. Betty Van Tenac and G. Dahlvig have also presented their comments. Dr. Morolli will summarise the situation on this difficult but important matter and release a proposal as soon as possible. having specific examples Delegates experiences are invited to send the relevant material to Dr. Morolli.

#### DETAILED CRITERIA


A comprehensive analysis on this subject has been developed by H.-W. Bosserhoff and brought to the attention of the other members of the working group. The subject should lead to the definition of more detailed criteria helpful to reach a more common understanding of the components of each criterion and of the relative weight and to produce forms to guide the jurors. Any <u>original</u> material developed on this topic at national level could be very useful for the further analysis of the working group.

# Genova '92

The exhibitors of GENOVA '92 were sent an information report presenting the REMARKS OF THE JURY of the exhibition, as indicated in a form filled by the team leaders.

The elaboration of the detailed marks given to each exhibit have allowed to highlight the average loss of points for each criterion of evaluation, as displayed in the following chart.



The chart shows, for instance, that the average of the exhibitors lost 6 points out of 25 for Condition and Rarity, etc.

The report was sent also to the Commissioners and the Jurors, but it may be that few Delegates have not received it. The can obtain it from the President of the Commission.

#### **OLIMPHILEX '96 IS TAKING OFF**

After a preliminary meeting in Atlanta last May, the organisation was finalised in meetings held in August in Houston and Atlanta. A General Committee includes representatives of the ACOG (Atlanta committee of Olynpic Games),

FIP, FIPO, APS, IOC and SPI (Sport philatelist international); the latter will act as consultant of the ACOG for the philatelic matters and its president, Marc Maestrone, will chair the O.C., with George Guzzio acting as General Commissioner. Preolympic activities in 1995 will take place in Atlanta in 1995. The show will be coordinated by M. Tecardi for the FIPO and M. Bergman for the CCO/IOC (Commission for Olympic Collectors).

# PHILATELY AT THE OLYMPIC MUSEUM IN LAUSANNE

On June 23rd the new Olympic Museum in Lausanne was officially opened. A room is devoted to Olympic stamps and coins, with 15 very large frames and 12 cupboards containing sliding frames, with a capacity of 10800 exhibit pages. The Museum hosts the Samaranch Olympic collection, donated by the President of the C.I.O. In the period from the opening to Sept. 30th a special philatelic exhibitions presented the first Olympic issue from Greece, with the rarities from the collections of the Museum, Tecardi, Bergman, Gironi, Bolaffi, Rosen and Dolianitis. Over the last three years Manfred Bergman has played a key role in the set up of this part of the Museum, after the late Heinrich Mannhart started the preliminary work, and in the preparation of the 1896 show.

# A CODING SYSTEM FOR THEMATIC EXHIBITS

- Organisers need a summary of the entries proposed by national Commissioners by major thematic areas (e.g. Zoology, Sport) in order to:
  - achieve a comprehensive and balanced selection of exhibits
  - support the selection of jurors among those proposed in order to ensure the most appropriate coverage of themes.

To satisfy this requirement it was sufficient a code (one digit) related to each thematic area; it

simplicity matches the still generic information on the entries. I adapted the scheme I developed in 1971 for the CIFT membership directory, as follows

- 1 Sport, Scouts and Games
- Science and TechnologyCommunications
- CommunicationHistory
- 5 International Organisations
- 6 Religion 7 Arts
- 8 Other Themes

This scheme, which was originated at the time of documentary collections, could be modified by eliminating "International Organisations", if it is considered more appropriate to classify the same according to their activity (e.g. U.N.O. under "History" and Red Cross under "Science").

Furthermore those situations which could be classified under two codes, like "Religious architecture" or "History of Religions" require a consistent coding. I took into consideration the noun, i.e. I coded both exhibits as "Religion".

2. The sequence of the exhibits in the frames must be the most attractive for the public and allow the easiest evaluation of the jurors.

In this respect the above coding system is inadequate. I added two digits to each code, in order to specify the theme more in detail.

The detailed sequence may depend on a more detailed definition specific of the thematic area (e.g. scientific classification) or a chronological and/or thematic classification. If a more detailed sequence is necessary, a separate index (from 0 to 9) could be specified only for the situations needing such a definition. For instance:

- 210 ZOOLOGY
- 210 1 ANIMALS IN ANTARCTICA
- 210 2 MAMMALS
- 211 DOG
- 216 BIRDS
- 216 1 FOOD OF BIRDS
- 216 2 EAGLES
- 216 3 PIGEONS
- 216 4 GEESE
- 216 5 PENGUINS
- The organisers may require to show the groups of exhibits in a different sequence, in order to match the actual position of frames on the ground and avoid discontinuities (e.g. exhibits of the same thematic area in two different zones of the exhibition hall) or highlight specific themes (e.g. Columbus exhibits in Genova).

This was achieved through an additional prefix (one digit code), giving the actual sequence of the thematic areas. For instance in Genova we had a "0" for the Colombian and Navigation exhibits, which were hosted in a separate area, a "1" for the Sport area, etc., a "7" for Zoology and Botany which required a larger room. This code, invisible for the public, determines the exact sequence for the catalogue, where entries have been classified just by frame number, the simplest and more effective method.

In summary each exhibit had the following coding structure:

#### PTXXI,

where P=Prefix, T=Thematic Area, XX=Detailed codes within T, I=additional sequence index (optional). Example: 72163 for Pigeons, where 7 = order of Zoology entries in the exhibition, 2 = Zoology, which combined with the 16 makes 216 (Birds) and with the addition of the 3 defines the Pigeons.

This approach was very effective. The only warning: when codes are used a systematic approach is necessary for ensuring an appropriate level of consistency. Otherwise the results of this effort will be in jeopardy.

The above notes reflect the need of an exhibition; if applied for achieving other objectives (like membership directories, bibliographies, etc.) some modifications may be necessary to take into account the peculiarities of the work to be performed. As a part of the Commission's programme also this subject will be developed more in depth. The detailed scheme as actually used at Genova '92 is available on request and it would be interesting to receive similar classifications from other Delegates.
